This Website collects some Personal Data from its Users.

Types of Data collected

Among the Personal Data collected by this Website, independently or through third parties, there are: name, email, cookies and usage data.

Full details on each type of data collected are provided in the dedicated sections of this privacy policy or through specific information texts displayed before the data are collected.

Personal Data may be freely provided by the User or, in the case of Usage Data, automatically collected during the use of this Website.

Unless otherwise specified, all the Data requested by this Website are mandatory. If the User refuses to communicate them, it may be impossible for this Website to provide the Service. In cases where this Website indicates some Data as optional, Users are free to refrain from communicating such Data, without this having any consequence on the availability of the Service or on its operation.

Users who have doubts about which data are mandatory, are encouraged to contact the Data Controller.

Any use of Cookies - or other tracking tools - by this Website or by third party service providers used by this Website, unless otherwise specified, is intended to provide the Service requested by the User, in addition the additional purposes described in this document and in the Cookie Policy, if available.

The User assumes responsibility for the Personal Data of third parties obtained, published or shared through this Website and warrants that he has the right to communicate or disseminate them, freeing the Owner from any liability to third parties.

Method and place of processing of collected data

Method of processing

The Controller takes appropriate security measures to prevent unauthorized access, disclosure, modification or destruction of Personal Data.

Processing is carried out using IT and / or telematic tools, with organizational methods and with logic strictly related to the purposes indicated. In addition to the Data Controller, in some cases, other parties involved in the organization of this Website (administrative, commercial, marketing, legal, system administrators) or external subjects (as suppliers of third party technical services, postal carriers) may have access to the Data, hosting providers, IT companies, communication agencies) also appointed, if necessary, Data Processors by the Data Controller. The updated list of Managers can always be requested to the Data Controller.

Legal basis of the processing

The Controller treats Personal Data relating to the User on the basis of consent of the same in relation to the browsing activity on the site or otherwise to sending information via the "Contact" form. The Data Controller also reserves the right to keep the list of e-mails sent via this form due to its legitimate interest in forming a history of contacts received via the website.

Place

The Data are processed near the operational headquarters of the Data Controller, except for the use of tools provided by providers resident in the United States and in the presence of an adequacy decision of the Commission pursuant to art. 45 GDPR (such as the Privacy Shield).

Retention period

Data relating to site navigation are kept for the duration of the browsing session. The Data relating to the contact form are retained up to the exercise of the right of opposition by the interested party.

Purposes of the processing of collected data

The Data concerning the User is collected for the purpose of finding the User's requests and for analyzing the statistics of visits on his website.

Feedback of the User's requests

Contact form (This Website): the User, by filling in the contact form with his / her Data (Name and e-mail address), consents to their use to respond to the requests formulated within the form.

Statistics

The services contained in this section allow the Data Controller to monitor and analyze traffic data and are used to keep track of User behavior.

Statistics collected directly (This Website): the Website uses an internal statistics system collecting navigation data (cookies and usage data), which does not involve third parties.

User Rights

Users may exercise certain rights with reference to the Data processed by the Data Controller. In particular, the User has the right to:

- Withdraw consent at any time. The User can withdraw consent to the processing of their Personal Data previously expressed.

- Propose a complaint. The User can lodge a complaint with the competent personal data protection authority or act in court.
